## GENERAL RENTAL TERMS AND CONDITIONS

### 1. **BOOKING**

The booking shall take effect upon the acknowledgement of receipt of the down payment, i.e. 30% per week. This down payment shall be rightfully withheld by the lessor in case of cancellation by the tenant.

### 2. **RATES**

The rental rates stipulated in the contract herein include the rental proper, heating, water, electricity, VAT, visitor's tax, air conditioning, bed linen and towels.

Any additional nights stayed beyond the period stipulated in the contract shall be billed as a supplement in proportion to the basic rate.

Should the tenant's stay be shortened for any reason, we shall under no circumstances be required to refund any rent corresponding to such an eventuality.

#### **SECURITY DEPOSIT**

A security deposit of €300 shall be paid by the tenant, on being given the keys on arrival, together with a cheque for €50 for cleaning if not done by the tenant.

This security deposit will be returned at your departure, less any deduction made for costs incurred as a result of damage or missing objects.

### 3. **RECEPTION AND PICKUP OF KEYS**

The TENANT shall take possession of the premises on the agreed date and shall pay the rental balance on the same day.

Rentals begin on Saturday at 5 pm and end on the following Saturday at 10 am at the latest.

If you plan to arrive outside these times, please let us know.

### 4. **OBLIGATION**

The tenant is required to comply with the residence and visitor rules and regulations governing your stay.

The apartments let may only be used as a holiday residence to the exclusion of any commercial activity.

The furnished apartment may UNDER NO CIRCUMSTANCES be occupied by more people than the number stipulated in the contract, for which the apartment is intended and fitted out accordingly. By default the contract will be terminated immediately without any refund.

No interruption in the utilities provided, and in particular heating, water and electricity, may be used to justify any reduction in rent if such interruptions are beyond the lessor's control.

The office declines all liability for any cuts or reductions beyond its control, and also for any lateness of any contractors carrying out repair work on the premises.

All pets must be declared and are subject to our agreement. If agreed, you shall be asked to pay a supplement of €6 per day and per pet.

We draw your attention to the fact that we have a salt water (*sea water*) pool 12m long, 4.5m wide and with a maximum depth of 1.4m

Our swimming pool is closed by a safety cover in conformity with current regulations. The opening and closing times are indicated in the rules and regulations and must be complied with. We stress, of course, that tenants with children must remain vigilant and shall be responsible for keeping a watch on them.

**The rules and regulations document must be signed and handed over the day of your arrival.**

### 5. **EQUIPMENT**

The apartment is completely furnished, we provide kitchenware, plates and dishes in sufficient number to accommodate the maximum number of people provided for in the rental contract herein.

Blankets, sheets, pillow cases and bath towels are provided.

### 6. **INVENTORY OF CONDITION AND FIXTURES**

At our arrival, when the keys are handed over, and at your departure we shall check the premises (*cleanliness*) and the inventory in the tenant's presence..

Any damage or loss shall be billed.
